

IDAPA 16 – Department of Health and Welfare Notice of Intent Facilitate Negotiated Rulemaking

The Idaho Department of Health and Welfare and the local Public Health District invites interested stakeholders to participate in negotiated rulemaking regarding 16.02.12 – Rules Governing Construction and Operation of Public Swimming Pools in Idaho.

This negotiated rulemaking will be limited to 16.02.14, section 032. Permit Fee and Plan Review Fee, 01. Fee Amounts.

Current Language: Fee Amounts. All applications shall be accompanied by payment of the permit fee of fifty dollars (\$50) annually for each swimming pool. A plan review fee per unit for each swimming pool is one hundred dollars (\$100).

Suggested language: 032. PERMIT FEE AND PLAN REVIEW FEE.

01. Fee Amounts. All applications shall be accompanied by payment of the permit fee of one hundred fifty dollars (\$150) annually for each swimming pool. A plan review fee per unit for each swimming pool is one hundred dollars (\$100). The Department of Health and Welfare and the Public Health Districts will review cost data every three (3) years to ensure that program costs are adequately covered and provide recommendations for fee changes as necessary.
